A motion was made / seconded, (Alfonse Peterson / Bob Boesch) to accept and approve the December 5, 2019 agenda as presented. Motion carried.

APPROVAL OF MINUTES

A. October 31, 2019 Board of Directors Meeting, Exhibit 1

A motion was made / seconded, (Alfonse Peterson / Bob Boesch) to accept and approve the October 21, 2019 Board of Directors Meeting minutes as presented, Exhibit 1. Motion carried.

FINANCIAL REPORT

A. October 21, 2019 Finance Committee Meeting Minutes, Exhibit 2

A motion was made / seconded, (Alfonse Peterson / Bob Boesch) to accept and approve the October 21, 2019 Finance Committee Meeting minutes as presented, Exhibit 2. Motion carried.

B. Chief Financial Officer Report, Exhibit 3

Dawnita Castle, CFO, commented that Castle Family Health Centers, Inc (CFHC) has approved the purchase of Blackbaud, a new accounting system for non-profits. As an FQHC Look-A-Like, CFHC has different reporting requirements such as 990 and UDS reports.

The current system, Meditech is owned by BMHD and CFHC has been paying \$2,090 per month for the use of the system. However, BMHD would not need that many accounting systems and this would reduce the monthly expense to \$470 for the GL module, fixed assets and accounts payable. Dawnita Castle, CFO, recommends BMHD staying with Meditech, should they decide on another partnership or venture they would already have the accounting system.

Dawnita Castle reported that Days Cash on Hand is at 514 days. Investments are doing well, BMHD has completed two projects that they paid cash for and did not touch the capital or grants. BMHD may want to invest more or invest in improvement into their buildings. It was also discussed at the Finance Committee to discuss specific questions with LPL Financial and Wells Fargo about the investments.

The Ung Goodwin Fund is low and the concern is that Wells Fargo is not following the investment guidelines. Wells Fargo does not need to be the Trustee of the Trust, BMDH can become the Trustee of the Goodwin Trust, and BMHD would be asking them to manage the investment itself.

For October 2019, BMHD had a net gain before depreciation of \$94,732 and after depreciation had a net gain of \$37,917. Included in the expenses was \$12,786 of SKDSC costs. YTD BMHD is looking at a net income after depreciation of \$56,570.

C. October 2019 Payroll, Electronic Payments and Check Register, Exhibit 4

A motion was made / seconded, (Alfonse Peterson / Bob Boesch) to approve and accept the October Payroll in the amount of \$9,158.42, Accounts payable in the amount of \$563,652.13 for a Grant Total Disbursement of \$572,810.55, Exhibit 4. Motion carried.

CHIEF EXECUTIVE OFFICER REPORT

Edward Lujano reported that David Thompson has now received his licensing by Denti-Cal with approval to go retro to September 18, 2019. BMHD is no longer liable for providing the professional services and utilizing our numbers for services for Atwater and Stockton facilities. Most likely within the next 3 months, this number will be de-activated because of non-use. Should BMHD ever need the number they would need to reapply.

All Roads Paving has completed the repaving of parking lots at the Bloss and Castle facilities.

On December 3, 2019 a patient was parked in a handicapped parking zone and she pressed the accelerator and went over the curve, knocked down a sign and ran into the retaining wall across the driveway. We offered to have her treated in urgent care and she decline. The driver was uninsured. The police were called for a report. Maintenance will repair the retaining wall.

He is still waiting to hear back from the Fire Marshall on the Bloss site and will keep the Board of Directors updated on any news.

Day Break had their Thanksgiving Luncheon and are hoping to do something for December. They also want to thank BMHD for their financial commitment.

Edward Lujano along with Fily Cale attended a Webinar put on by California Special Districts on Website Compliance for 2020. We are now updating our website to meet 2020 compliance, by adding 2 links to the State Controller for reports "By the Numbers" and "PublicPay". We will also add a link to the Municipal Service Review "LAFCO".

There were some roof leaks during the last rain storm at both facilities. Joe Bristow, Sales Representative for Duro-Last representative was contacted as he had given us the warranty for the 2 locations. Platinum Roofing worked on the Bloss Building and Cool Roofing worked on the Castle facility. Cool Roofing is no longer in business. Joe Bristow contacted Platinum and they are willing to take the coverage and help at the Castle location. Edward Lujano spoke to Duro-Last today and they will be here either today or tomorrow to see what they can do to start mitigating some of the leakage until after the rain storm. They said that they are responsible and will cover 100% of the damages inside and out. He will keep the board of directors updated.

Ralph Temple, Legal Counsel, made the comment, the company no longer in business did not pay Duro-Last everything, which Edward Lujano stated that this is the understanding. There is a possibility that if there is a lien on the building, a pre-lien notice that you get by subs, that if they don't pay by the general, they put a lien on your building. There could be a complication, he is not saying that there is always a possibility.

OLD BUSINESS / REPORTS

A. Castle Family Health Centers, Inc (CFHC) Report

Peter Mojarras reported that CFHC is keeping busy, they have been averaging over 12,000 visits per month. CFHC is seeing more private pay patients than before at the Winton location.

He thanked the board of directors for their attention to the roof leaks. He was on the roof himself multiple times talking to the guys to make sure the work was done professionally and took care of all the problems.

CFHC continues to work with Legacy Health Endowment in the Turlock area, they are part of Emanuel Hospital. CFHC also wants to continue to strengthen with Mercy Hospital. Legacy is willing to invest dollars to support a pain specialist that is being brought in and needed for the community. He has a private practice in Turlock and will be at CFHC two times per month.

Harleen Aujila, MD, Nephrologist, will be joining CFHC specialists' panel, which consists of cardiology, nephrology, pain management, podiatry, acupuncture, chiropractic. Legacy Health also introduced CFHC to a part-time psychiatrist, Nino Adams, MD.

A federal HRSA Audit will be held in mid-January 2020. It's a lot of work and everyone is working toward preparing for it.

CFHC is also working on building a relationship with Golden Valley Health Centers on OB services. In many communities, OB physicians no longer want to deliver, only see prenatal care. Merced County has a Locum Group and will move toward a Laborists Group in the next few months. CFHC has an OB that does not deliver and Dr. Scales delivers, but only does c/sections.

CFHC moving toward Delhi School District to have a school based clinic on their campus. This will bring access to students and school families.

Kory Billings asked if there was anything that BMHD could do to help CFHC with promoting their health services. Is signage sufficient, people need to know about services, do provider bio article and perhaps have BMHD sponsor it. This could also be posted on the BMHD website. Peter Mojarras will present this to the CFHC Board of Directors.

B. Bloss Board Member Report

B. Update and Approval of Ung Goodwin Trust Fund Policy, Exhibit 7

An update was provided with input from legal counsel.

A motion was made / seconded, (Alfonse Peterson / Bob Boesch) to approve and accept the updated Ung Goodwin Trust Fund policy, Exhibit 7. Motion carried.

Ralph Temple, Legal Counsel, commented that the Board of Directors has had some concern or discontent about the performance of the Bloss Trust with Wells Fargo Bank. If there are other funds that the Board of Directors feels are doing better and want to ask critical questions about why BMHD isn't making these returns. It ought to be very specific and maybe send them ahead of time.

Kory Billings commented that Wells Fargo has failed to provide reports in a timely or at all manner; BMHD has asked them to provide a copy of where they are versus the Standard & Poors Index and we may get that 2 times per year.

Alfonse Peterson commented that if Wells Fargo Bank uses the Standard & Poors Index as a measure and when BMHD gets the report and in looking at the index, BMHDs earnings are less than 5%. Standard & Poors Index is up 10% - 15% for the year.

Kory Billings stated that his understanding is that the only thing they judgment themselves is against what their own standard is. They are only showing in the reports they are sending us, here is where our corporate standard is and we're a little bit higher than our corporate standard and they're not showing what the industry is showing.

An annual Bloss Trust meeting with Wells Fargo Bank was not held last year, its' been difficult to schedule a meeting and BMDH is not getting their reports.

Kory Billings commented, why aren't they required to look at what BMHDs needs are and what its own policies and procedures are with the money that is eventually coming back to BMHD. Who are they liable to? At one time this Board of Directors was the Trustee of the Trust at the very beginning.

BMHD has a policy and procedure on how they want it, Wells Fargo Bank is not following the policy and procedure, they are following their own.

REVIEW OF DISTRICT FINANCIAL STATEMENTS, EXHIBIT 2

Dawnita Castle, CFO, reported that as of October 31, 2019 the operating cash balance was at \$1,886,318. Days on Hand did decrease to 514, down about 7 days due to funding \$10,000 to MassMutual and 2 other checks. In 2016 Cash on Hand was at 50 days; 2018 was at 156 days and June 2018 it increased to 682 days.

The capital improvement, grants and BBVA are not included in this amount balance. In October, capital improvement investment was up \$8,000 and grants up \$4,000, there was also \$800 in BBVA gain interest, and the interest is currently at 1.98%.

Alfonse Peterson asked what BMHD has with MassMutual. Dawnita Castle replied that this was for the 403B Retirement.

A discussion was held on investments.

BMHD funded two major projects and used cash instead of the capital improvement. BMHD also funded an additional \$500,000 in each investment account and opened a \$500,000 Money Market account at BBVA.

For October 2019, BMHD had a net gain before depreciation of \$94,732 and a net gain after depreciation of \$37,918. YTD after depreciation was \$56, 570 and in October 2018 YTD, BMHD was at a loss of \$285,000.

A motion was made / seconded, (Kory Billings / Edward Lujano) to approve and accept the Review of District Financial Statements, Exhibit 2 as presented. Motion carried.

SKDSC FINANCIAL REPORT, EXHIBIT 3

Dawnita Castle reported that for October 2019, SKDSC had total expenses in the amount of \$12,786, which was up about \$513. This was due to invoices that were sent to BMHD late, they actually went to the facility at Sierra Kings and are from 2018.

A motion was made / seconded, (Kory Billings / Edward Lujano) to approve and accept the SKDSC Financial Report, Exhibit 3 as presented. Motion carried.

Bloss Memorial HealthCare District Operations Summary Report Five Months Ending November 30, 2019 BMHD had a total net gain before depreciation of \$58,109 for the month compared to a net gain of \$44,896 last year. Expenses include \$10,659 of SKDSC costs.

The November 30, Operating Cash Balance was \$1,797,372 and Days Cash On Hand increased to 613 Days*. In October the DCH was 514 Days.

* Days Cash on Hand (DCH) = Operating Cash / Average Daily Expense (excluding depreciation). DCH indicates Bloss's ability to cover operating expenses. The Benchmark for Health Centers is a minimum of 90 Days.
